Greetings Soberstockers -

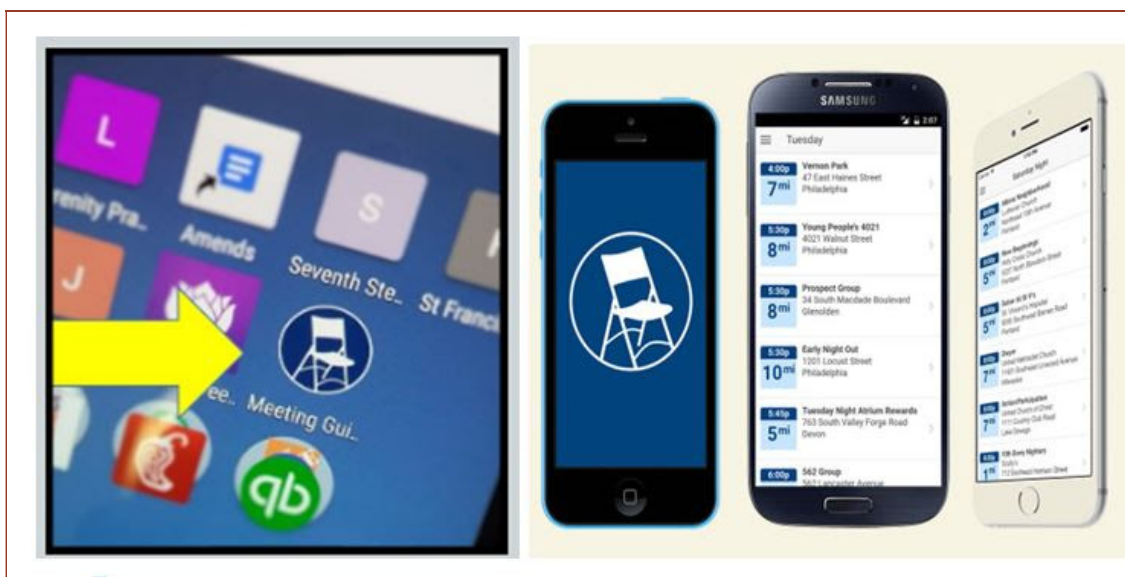
