The next Heartland Intergroup Representative meeting will be held via Zoom on October 12, 2020. Information will be sent out on October 8, 2020 to the Representatives. Elections will be held for Chairperson/Vice-Chairperson.

Per our current by-laws Article II Section 1-11: Section 1 (OFFICERS AND ELECTIONS)

- The official body of Intergroup shall consist of:
- One (1) Representative or one (1) Alternate from each AA group in the Intergroup area. No Representative or alternate shall represent more than one group.
- District III Liaison member to Intergroup.

- Candidates must have at least one (1) two (2) years of continuous sobriety when placed in nomination.
- Officers elected by the Representatives shall consist of:
- Chairperson
- Vice-Chairperson
- Secretary
- Treasurer

Section 2 (ELECTIONS)

Officers shall be elected at the regular November Intergroup meeting and installed at the January meeting. Officers hold office for a period of two (2) years, the Chairperson and Vice-Chairperson to be voted upon in even number years, the Secretary and Treasurer to be voted upon in odd number years.

Section 3 (NOMINATIONS)

- At least 30 days prior to the October Intergroup meeting, the AA community must be informed of the positions up for election.
- At the October Intergroup meeting, any member of AA may stand for one but not both positions up for election, either by:
 - Being present at the October Intergroup meeting and announcing their intention to run, or,
 - Presenting their intention to run in writing to the Intergroup Office Manager or any of the current officers at the September meeting. <u>Section 4</u> (ELIGIBILITY)
 - No member may hold the **same** position as an officer of Intergroup for more than two (2)consecutive full terms.
 - No member may be an officer of Intergroup for more than three (3) consecutive full terms.
 - If no one else stands for the position, the above requirements are waived.

Section 5 (FAILURE TO ATTEND MEETINGS)

Any officer who misses two (2) consecutive Intergroup Representative meetings without notice can be removed from office by vote of the Representatives.

Section 6 (VOTING RIGHTS)

Only Representatives or their Alternates shall be eligible to vote in

the election process. This rule provides one (1) vote per group properly represented at the election meeting. Intergroup Representatives may only represent one group and may only cast a ballot for one group. The officers other than the chairman each have a vote. If any vote ends in a tie, the chairman shall cast the tie-breaking vote.

Section 7 (TALLYING THE VOTE)

Before voting occurs, it shall be the duty of the Chairperson to appoint two (2) or more tellers to see that the ballots are properly executed, counted and tallied.

<u>Section 8</u> (VOTES REQUIRED FOR ELECTION)

- Election shall be by secret ballot; Secretary before Treasurer.
- Vice-Chairman before Chairman.
- The candidate receiving a majority of the votes for a single office shall be declared elected.
- When there are more than two (2) candidates for a single office, and none receives a majority of the votes cast, the two (2) receiving the most votes on the first ballot shall be listed on the second ballot, which shall be voted on to determine the majority winner.

Section 9 (VACANCIES)

Any vacancy of a permanent nature, whether for cause or resignation, shall be filled by a vote appointment of the Representatives for the unexpired term.

<u>Section 10</u> (APPOINTMENT OF OTHER COMMITTEE HEADS AND WORKERS)

The Chairman Representatives shall appoint all standing committees with the approval of the representatives.

Section 11 At any normally scheduled meeting, a group representative may propose the recall of an officer. The representatives will state their case for recall and discussions may take place. Once discussions have finished, the recall request will be tabled so all representatives can take the information back to their groups. At the meeting in the following month, further discussions may take place and a vote will be taken. Should the

vote to recall pass, the officers term will be filled as described in Article II, Section 9.

Saturday: All the meetings are listed in the Virtual Program, which is available on the Area website (area15aa.org). All meetings will have the additional safety feature of a waiting room; the host will let you in to the meeting once the meeting room has opened. Meeting rooms will open 15 minutes prior to meeting start except for the Area business meeting, which will which opens at 8am to allow a one-hour registration period; please enter early to allow time for the entry process.

Sunday: As you enter the main meeting, you will be ushered into a District break-out room so that your District can take roll call and determine the vote count. We will be utilizing a similar renaming process as our last quarterly and would appreciate your renaming yourself in advance whenever possible. If you rename yourself in your zoom account, your name will be established for each meeting all weekend, as opposed to , renaming yourself in the meeting directly, you will need to repeat that process for each meeting. Once the Business meeting is complete, we will take a short break and then open the voting assembly. The process for the voting assembly will be explained before the business meeting is closed.

If you need to step away, please turn off your video during your absence, similar to leaving the room when you attend in person. This will protect your vote. Should you get disconnected, please dial back in and you will be re-admitted under the same user account. Please utilize the chat function with any questions or concerns during the meeting or call the Help Desk.
