IT IS INTERGROUP BOARD ELECTION TIME!!

- C. Make certain that all necessary materials are made available at Intergroup meetings, such as sign-in sheets,

etc.

- D. Perform other duties that the Chairperson may request.
- E. Must be familiar with the By-Laws and 36 principles.

TREASURER

The duties and service obligations of the Treasurer include:

- A. Require skills of current bookkeeping system.
- B. Prepare a monthly financial statement and present this report at Representatives meetings.
- C. Attend all Intergroup-sponsored functions.
- D. Perform any other duties the Chairperson may request.
- E. Must be familiar with the By-Laws and 36 principles.





An introduction to A.A.: describes who A.A.s are and what they have learned about alcoholism. For all who think they may have a drinking problem. General Service Conference-approved.

My AA life began after my first meeting, but then in a different sense it really didn't begin till I learned the AA program of action and put it into practice.

At first I thought just going to meetings and trying to practice the Twelve Steps as written on the clubhouse wall was living AA on a daily basis. Indeed, I had found a new happiness and developed many new wonderful friends.

My phone was just ringing off the hook and I was going to loads of meetings and coffee houses with AA friends afterward. I was a regular social butterfly! I was involved with a religious organization and remained very busy.

Yet I had not actually gone through the Twelve Step process with a sponsor. What's the hurry-I'm really doing well aren't I? Well maybe not!

One night I was alone on Hollywood Boulevard after a parade and somehow marched into a bar on Las Palmas Blvd; on my lips were: "Gin & tonic please!" Thank God those words were never spoken!

Rushing home, I prayed that God would bring a sponsor to take me through the steps and in a few weeks he did. Of course, one of the major parts of my post-step life was Step Ten of which I could never had done until I have learned, and lived, the middle steps. This is what I mean (Read page 84):

Continue to watch for selfishness, dishonesty, resentment, and fear. Learned in Step Four

When these crop up, we ask God at once to remove them. Learned in Step Six & Seven We discuss them with someone immediately. Learned in Step Five And, make amends quickly if we have harmed anyone. Learned in Steps Eight & Nine Then we resolutely turn our thoughts to someone we can help. Love and tolerance of others is our code.

So, had I been living in the spirit of Step Ten, I would never have marched into that bar to begin with, and even if I did, I would have asked God at once to put me back on the beam. I have not had to drink since my first AA meeting—a long time ago—but if not for Step Ten, I certainly would have.

The Mary Lyons Detox Center has no groups signed up to bring experience, strength, and hope to their facility from now until January 2022. This is usually done by a bid process once a year at the District 3 Meeting. In keeping with our 5th Tradition which states, "Each group has but one primary purpose- to carry its message to the alcoholic who still suffers." We are reaching out to you! Meetings are Wednesdays at 8:00 PM and Sundays at 2:00 PM. If any groups or AA members are willing to go to the detox center and carry the message please reach out to the Heartland Intergroup office manager at officemanager@heartlandintergroup.org.

In these trying times detox has a few new rules:

1. Must wear a mask at all times

2. Only one person may go in at a time. This means you will run this meeting independently. In order to keep safety a priority one member per meeting.

3. Temperature checks at the door. The facility may check your temperature before you go to the meeting room.

Tradition Ten – An Essay by Bill W. September 1948

To most of us, Alcoholics Anonymous has become as solid as the Rock of Gibraltar. We like to believe that it will soon be as well-known and just as enduring as that historic landmark. We enjoy this pleasant conviction because nothing has yet occurred to disturb it; we reason that we must hang together or

die. Hence we take for granted our continued unity as a movement.
But should we? Though God has bestowed upon us great favors, and though we are bound by stronger ties of love and necessity than most societies, it is prudent to suppose that automatically these great gifts and attributes shall be ours forever? If we are worthy, we shall probably continue to enjoy them. So the real question is, how shall we always be worth of our present blessings?
Seen from this point of view, our AA Traditions are those attitudes and practices by which we may deserve, as a movement, a long life and a useful one. To this end, none could be more vital than our Tenth Tradition, for it deals with the subject of controversy – serious controversy.

On the other side of the world, millions have died even recently in religious dissension. Other millions have died in political controversy. The end is not yet. Nearly everybody in the world has turned reformer. Each group, society, and nation is saying to the other, "You must do as we say, or else." Political controversy and reform by compulsion have reached an all-time high. And

eternal, seemingly, are the flames of religious dissension.

Being like other men and women, how can we expect to remain forever immune from these perils? Probably we shall not. At length, we must meet them all. We cannot flee from them, nor ought we try. If these challenges do come, we shall, I am sure, go out to meet them gladly and unafraid. That will be the acid test of our worth.

Our best defense? This surely lies in the formation of a Tradition respecting serious controversy so powerful that neither the weakness of persons nor the strain and strife of our troubled times can harm Alcoholics Anonymous. We know that AA must continue to live, or else many of us and many of our fellow alcoholics throughout the world will surely resume the hopeless journey to oblivion. That must never be.

As though by some deep and compelling instinct, we have thus far avoided serious controversies. Save minor and healthy growing pains, we are at peace among ourselves. And because we have thus far adhered to our sole aim, the whole world regards us favorably.

May God grant us the wisdom and fortitude ever to sustain an unbreakable unity.


